

Health & Safety Protocols

- Each site will have its own health and safety protocols. These will be communicated in the pre-show information posted on the website and in Contest Dynamics
- It is expected that all members of all units follow all published safety protocols



9/24 Clinic Format Linfield Event

- Clinic style event
- 1st half:
 - Bands will have a large block of time TBD
 - On the field performers will receive on field clinics.
 - Performers may wear "rehearsal attire"
- 2nd half:
 - Regular performance
 - Bands will receive comments and scores in 6 captions
 - Bands will only receive their own scores
 - Non-competitive event No trophies or placements will be awarded
 - Performers in "uniform" encouraged



Judging Panels

8 Adjudicator Panel

Classification A/AA/AAA/AAAA

Prelims – Bands compete in A/AA/AAA/AAAA based on their size.

Prelims – Schedule order is A-AA-AAA-AAAA.

Finals – all units compete in Open class, regardless of size, in reverse prelims score order.

Class	Description	Min-Max Performance	Interval
AAA	90 members or greater	5 - 10 mins	13 mins
AAA	60 – 89 members in size	5 - 10 mins	13 mins
AA	50 – 59 members in size	5 - 10 mins	13 mins
Α	49 members or less	5 - 10 mins	13 mins

Note that the above classifications were updated 9/9/2022 to reflect an NWAPA Board decision to keep 2021 classification structure.



Classification

- Bands have provided a preliminary performer number and intended classification prior to the fall draw.
- Bands will provide a final performer number and classification by September 9.
- Bands not providing a differing number/classification by September 9 will be placed in the class noted during the fall draw.
- Classification changes due to number of performers change will be handled on a case by case basis.



Classification

- Bands may enter in Exhibition class for a specific event (e.g. as a host band), or for the entire season.
- At any time during the season, a band may choose to compete up a class (A to AA, A to AAA, AA to AAA, AAAA).
- Classification change request must be submitted via email to NWAPA Fall Vice President. Event schedules that have been set at the time the written request is received may be adjusted or left in a 'locked' status at the discretion of NWAPA Fall Vice President, Contest Coordinator, or President.
- Bands that have elected to switch classification must remain in the new class for the duration of the NWAPA Fall Season.



Entry/Exit Protocol

- Maps and information on interval time and pathways will be available in the director's packet on the website and Contest Dynamics.
- Certain venues may require special consideration when determining precisely when and where interval time begins and ends. The Contest Administrator may designate additional boundaries or exemptions in order to facilitate the practical transition of bands moving in and out of the performance area.



Performance Timing

- Performance timing and judging shall begin with the first note of music played or the first meaningful step taken by a performer after the announcer has completely finished introducing the band. All performance timing and judging shall cease at the conclusion of the band's performance.
- Any coordinated performance effort prior to the announcement will not be judged or included in performance time.
- Units can elect to pre-record their announcement and play it through the front ensemble sound system. Please make the contest coordinator/ NWAPA field staff aware if you choose to do this.



Non Competitive Area

- New policy !!!
- The area beyond 15ft from the front sideline outside the contest field is not part of the competition area.
- Student conductors may perform from stationary podiums in this area, provided their performance is limited to conducting or playing an instrument in a stationary fashion, and the student remains on the podium.
- Equipment may be retrieved to and from this area for safety reasons, but equipment should not be moved in or out of this area during a performance as part of a planned effect.
- Stationary sound equipment may be placed in non-competitive area provided it does not move.
- Some venues do not allow a full 15ft beyond front sideline. Please be flexible in order to keep performers, staff, judges, audience, safe.



Electronics

- Student performer sound board operators must remain in the competition area.
- Venues may designate a remote mixing area for adult staff only if space is available.
- Non performers may NOT trigger effects or manipulate equipment to generate effects during performance.
- See Fall Member Handbook for detailed Electronics policy.



Props / Vehicles

- Props must fit through designated entry areas.
- Tunnel at Autzen Stadium (UO) is known to be the most restrictive.
 - Height : 6'9"
 - Width : 10'6''
- No additional time will be allowed for props to be constructed in the contest area.
- See Fall Member Handbook for comprehensive requirements regarding props and performer safety.
- Vehicles that tow props, instruments, and equipment must be in proper working condition such that they do not damage the field turf or other surfaces by fluid leakage or marks from tires.
- Show Sponsors reserve the right to prohibit vehicles from entering the contest area that are observed to be in poor condition with potential to damage surfaces or leave oil, gas, or other residue.

Full Performance Recording Judges multi-track commentary

- NWAPA sanctioned video may not be reproduced or distributed beyond use for educational purpose.
- Show Sponsors are not required to provide a separate video recording area for individuals.
- Independent video recording may only occur with the permission of the Band Director of the unit being recorded.
- The NWAPA will not facilitate or police independent video recording, other than it may not be disruptive to judging, contest administration or spectators.

Community Promotions

The NWAPA may facilitate 3rd party organizations maintaining a presence (booth / table) at your event. We ask that you honor requests when possible.

You may charge a reasonable vendor fee to organizations that are selling merchandise.



Health & Safety Protocols

- Make sure you know what the protocols are for your county/city/district/venue:
 - Masks
 - Vaccination
 - Social Distancing
 - Capacity
- Provide all details/rules for performers and spectators attending the event. Must be outlined in Directors Information.
- Show Sponsors are responsible for enforcing Health and Safety Protocols.



Other Reminders

- Show Sponsor Fee
 - 1st half due September 1st
 - 2nd half due day of your event
- Trophies
 - Each event will be a bit different based on type of contest and number of entries.
 - We will provide a list of necessary awards.
 - Awards must be permanent tokens of achievement but do not have to be large.
- Judges/Staff Hospitality (Food)
 - Pre-packaged or boxed meals is preferred
- Judge Travel/Transportation
 - Judges transportation is arranged or coordinated by NWAPA Operations Admin.
 - All judges' and NWAPA staff stipend and travel expenses will be paid by the NWAPA. The show sponsor will not be invoiced for these costs.
- Unit Entry Fees are collected and retained by the NWAPA.
- Show Sponsor will retain all other income i.e. tickets, concessions, programs etc (based on your arrangement with your venue).
