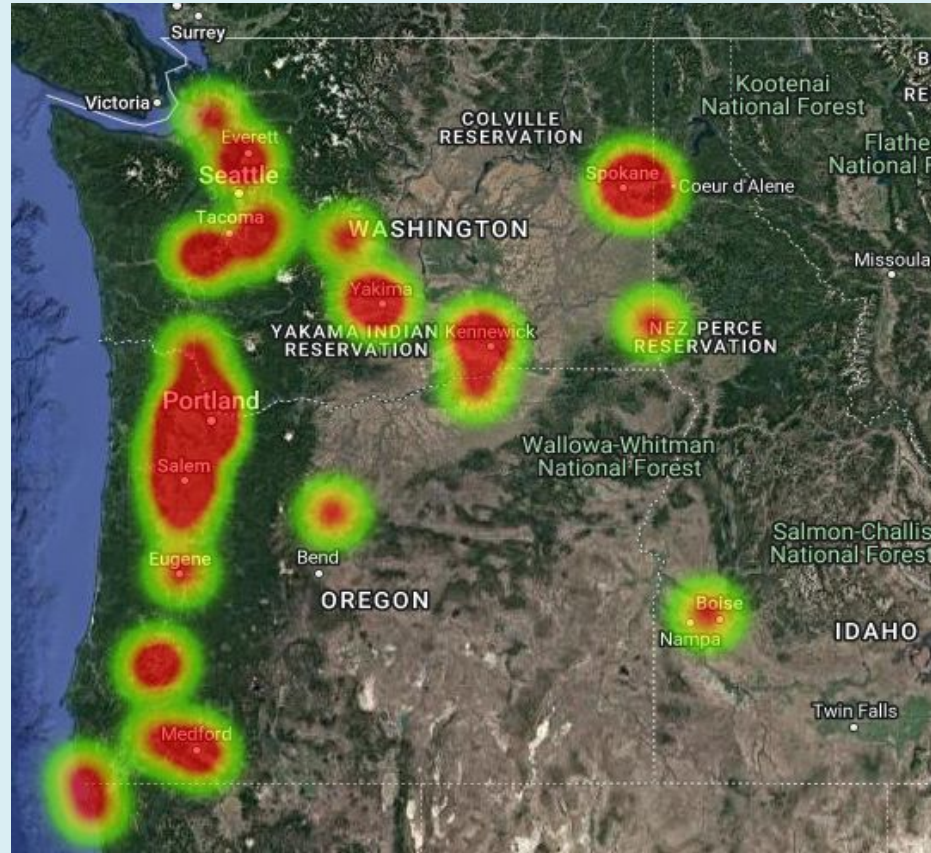

# Judges Feedback Process Reminder

- Judge Statistics
  - 43 different judges for 70 spots
  - 16 came in multiple times including 5 of 8 championship judges
  - 51% PNW, 28% CA/NV/UT, 14% Midwest, 7% East
  - 49% National adjudicators (BOA/DCI/WGI)
- Instructions and Link to separate judge feedback form
  - Person providing feedback MUST self identify
  - Can comment positive or negative on a specific judge
- If commenting about a judge, a video link must accompany the form when returned.
- Without the form and access to a video, the feedback will not be reviewed nor will it be considered a formal actionable item.
